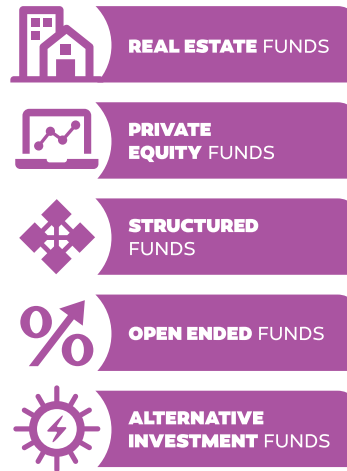

Launch, Incorporation and Transfers In

We assist with the set-up of new structures, as well as transferring in existing structures from other service providers. We work with our clients' chosen legal advisors and other parties to provide a tailored on-boarding plan and service.

Valuations and Financial Reporting

Our technically proficient accountancy teams maintain full accounting records for all entities within the fund structure, provide net asset value ("NAV") calculations for investor reporting and dealing, prepare financial statements in accordance with accounting standards (IFRS, UK GAAP and US GAAP), coordinate and arrange tax reporting and liaise with auditors and coordinate audits.
